Mark schemes are prepared by the Lead Assessment Writer and considered, together with the relevant questions, by a panel of subject teachers. This mark scheme includes any amendments made at the standardisation events which all associates participate in and is the scheme which was used by them in this examination. The standardisation process ensures that the mark scheme covers the students' responses to questions and that every associate understands and applies it in the same correct way. As preparation for standardisation each associate analyses a number of students' scripts. Alternative answers not already covered by the mark scheme are discussed and legislated for. If, after the standardisation process, associates encounter unusual answers which have not been raised they are required to refer these to the Lead Assessment Writer.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of students' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

Level of response marking instructions

Level of response mark schemes are broken down into levels, each of which has a descriptor. The descriptor for the level shows the average performance for the level. There are marks in each level.

Before you apply the mark scheme to a student's answer read through the answer and annotate it (as instructed) to show the qualities that are being looked for. You can then apply the mark scheme.

Step 1 Determine a level

Start at the lowest level of the mark scheme and use it as a ladder to see whether the answer meets the descriptor for that level. The descriptor for the level indicates the different qualities that might be seen in the student's answer for that level. If it meets the lowest level then go to the next one and decide if it meets this level, and so on, until you have a match between the level descriptor and the answer. With practice and familiarity you will find that for better answers you will be able to quickly skip through the lower levels of the mark scheme.

When assigning a level you should look at the overall quality of the answer and not look to pick holes in small and specific parts of the answer where the student has not performed quite as well as the rest. If the answer covers different aspects of different levels of the mark scheme you should use a best fit approach for defining the level and then use the variability of the response to help decide the mark within the level, ie if the response is predominantly level 3 with a small amount of level 4 material it would be placed in level 3 but be awarded a mark near the top of the level because of the level 4 content.

Step 2 Determine a mark

Once you have assigned a level you need to decide on the mark. The descriptors on how to allocate marks can help with this. The exemplar materials used during standardisation will help. There will be an answer in the standardising materials which will correspond with each level of the mark scheme. This answer will have been awarded a mark by the Lead Examiner. You can compare the student's answer with the example to determine if it is the same standard, better or worse than the example. You can then use this to allocate a mark for the answer based on the Lead Examiner's mark on the example.

You may well need to read back through the answer as you apply the mark scheme to clarify points and assure yourself that the level and the mark are appropriate.

Indicative content in the mark scheme is provided as a guide for examiners. It is not intended to be exhaustive and you must credit other valid points. Students do not have to cover all of the points mentioned in the indicative content to reach the highest level of the mark scheme.

An answer which contains nothing of relevance to the question must be awarded no marks.

[4 marks] (b) four tips to reduce the amount of sugar in babies’ and children’s diets. [4 marks]</p>

<p><i>Award one mark for each of four instructions for brushing babies’ and children’s teeth, up to a maximum of 4 marks.</i> <i>Award one mark for each of four tips to reduce the amount of sugar in babies’ and children’s diets, up to a maximum of 4m.</i> NB</p> <ul style="list-style-type: none"> • Candidates may not present the four points for 7(a) and the four points for 7(b) neatly on the lines provided. Instead they may ‘bunch up’ the points. This is allowed within each part of the question. Maximum of 2 marks. • The maximum mark is 4 for each part even if more than four valid points have been made. • Points that belong in 7(a) but appear in the answer to 7(b) and vice-versa are not to be rewarded. • Examiners are reminded that slashes (/ or //) indicate alternative options, only one of which can be accepted. • Emboldened or underlined text must be included in answer. • Brackets indicate optional content. <p>7(a)</p> <ul style="list-style-type: none"> • Start brushing baby’s teeth as soon as first milk tooth breaks through / appears • Brush your child’s teeth for about two minutes // twice a day • Use fluoride toothpaste. <i>Do not accept “Fluoride toothpaste helps to prevent/control tooth decay.”</i> • Make sure children spit out excess toothpaste / don’t eat or lick toothpaste from the tube • Do not rinse with water after brushing • Use a mirror to help them see where they are brushing • Don’t let them run around with a toothbrush in their mouth <p>NB: <i>Do not accept reference to Brush DJ/app that plays music</i></p> <p>7(b) NB: <i>Answers must be presented as tips/advice, not just information</i></p> <ul style="list-style-type: none"> • Avoid sugar sweetened drinks // don’t give juices / sugary drinks <p>Reference to giving children milk or water must be as alternatives to sweet sugary drinks</p> <ul style="list-style-type: none"> • Don’t give juices or sugary drinks in a bottle with a teat • Don’t give/let children have lollipops. <i>Do not accept “Lollipops are particularly damaging.”</i> • Give sweet foods and fruit juice only at mealtimes • Don’t give biscuits or sweets as rewards • Ask for sugar-free medicine where possible 	<p>Utilise information contained in texts</p> <p>Understand texts in detail</p> <p>Respond to texts</p>	<p>Up to 4 marks</p>

<ul style="list-style-type: none"> • Award up to two marks for each response up to FOUR marks. Candidates may express the ideas below in their own words. • Candidates may 'bunch' their answers. This is allowed. • There must be a valid link between the chosen presentational device and the reason why it would 'make it easy for people to understand', to get the two marks. • Colour: colour per se is a presentational device. 'The text uses colour/is colourful' = 1. When attached to another device, it is being used as a qualifying adjective and is not to be awarded as a separate presentational device – 'coloured heading' = 1(mark awarded for identification of "heading"). • Pictures & Colour: All comments must refer to the specific picture/colour in the text. Comments which could apply to any text are not to be accepted. • <i>Apply the following test:</i> <i>If the named device appears in the text, award 1 mark.</i> <i>If the explanation/reason which follows shows no evidence that the candidate is commenting on this particular text, withhold 2nd mark.</i> • Do not accept 'The picture tells you what the text is about.' • Examiners need to identify the difference between a statement of what is there and a comment on how it makes it easier to understand. • Do not accept a simple description or account of what is in the picture as an explanation of why it makes the text easier to understand. <p>Presentational devices in Source B:</p> <p><i>NB no subheadings/subtitles</i> Possible answers include:</p> <ul style="list-style-type: none"> • Title / Headline (NHS Choices) (<i>valid explanations unlikely</i>) • Coloured webpage banner suggests easy navigation and more information available • Blue colour links to NHS logo and reminds of nurses' uniforms, doctors' scrubs etc • NHS logo adds authority/seriousness • Orange colour possibly reminds that fruit/fruit juices contain a lot of sugar and are bad for teeth. Orange colour for word "choices" is familiar to users of NHS website. <i>Award comments on the word "choices" in terms of reminding parents that controlling sugar is parents' responsibility.</i> • Photograph of dad with baby indicates importance of parental involvement and defies gender stereotype • Cartoon/ picture / graphic is visual representation of "evil" of sugar and its danger to teeth. 	Identify how texts are presented. Respond to texts.	<p>Up to 4 marks</p>	

<ul style="list-style-type: none"> • Idea of sinister sugar is reflected in black colour and evil eyes. • paragraphs/sections make it easier to read. <p style="text-align: center;"><i>NB: Award 4 marks for a response which satisfactorily explains two elements of the "Sugar" cartoon.eg tooth and eyes/black colour</i></p>
