

No Meat Day in Local Schools

Every week, for one day, students attending school meals at the two schools will tuck into vegetables, cereals and soya proteins, but no animal products. Head teacher at one of the schools, Shona Wilkinson, says, "We think it is important that young people learn the benefits of not eating meat. It is good for the children and good for the planet. 
