## DATA SHEET FOR ANGLING

## **ANGLERS**

Anglers try to catch fish.



In competitions, anglers try to catch the biggest total weight of fish.

#### **ANGLING COMPETITION**

Some competitions start with quarter-finals, then have semi-finals and a final.

Each quarter-final has 9, 12 or 15 anglers.

The table shows the number of anglers who qualify for a semi-final.

Qualifiers from each semi-final take part in the final.

Each semi-final has 12, 16 or 24 anglers.

The table shows the number of anglers who qualify for the final.

### **WEIGHT**

The weight of each fish can be measured in

pounds (lb) and ounces (oz)

or

kilograms (kg) and grams (g).

1 lb = 16 oz

## **Converting ounces to grams**

To convert a weight from ounces to grams, use the formula

y = 28.35x

where

y is the weight in grams

x is the weight in ounces

#### **EXAMPLE**

Convert 376 ounces to grams.

 $28.35 \times 376 = 10659.6$ 

376 ounces is 10 659.6 grams.

## DATA SHEET FOR COUNCIL TAX

If you own or rent your home, you usually have to pay Council Tax.

There are eight bands of Council Tax, from A (lowest) to H (highest).

The more valuable your home, the higher your band and the more money you have to pay.

The table shows the council tax PER HOME for each band in three areas of Waybridge.

Council Tax covers the period from April 1st of one year to March 31st of the next year.

In Waybridge, you can pay your Council Tax in 10 monthly payments from April to January.

You normally pay the full Council Tax if you are aged 18 or over.

You get a 25% DISCOUNT if you are the ONLY person aged 18 or over living in your home.

#### **EXAMPLE**

Tina is 32 and lives on her own in Kribly.

The Council Tax band for her home is band C.

- The band C amount for Kribly is £1587.79 per year.
- Tina gets a 25% discount, so she pays £1190.84 per year.
- She pays in 10 monthly payments.

$$1190.84 \div 10 = 119.084$$

- This is rounded to the nearest pound.
- An adjustment is made in April to give the correct total for the year.

$$1190.84 - 119 \times 9 = 119.84$$

- Tina pays £119.84 in April.
- She then pays £119 each month from May to January.

#### **DISABLED PEOPLE**

If you are disabled and your home is adapted for your needs, your home is re-banded.

It is re-banded to one band LOWER THAN the usual band for that home.

You can still get the discount for living alone.
