Supporting work **should** be taken into the examination room and **must** be submitted for external assessment together with your final examination work. The submission will be assessed as a whole. The supporting work must consist of not more than **four** sides of paper (**two** sheets) no larger than A1 size on which smaller works may be mounted. You may work on smaller paper if you choose.

The examination assesses your response to visual stimuli and involves direct observation from primary sources, recording, analysis and 2D and/or 3D development.

At the end of the examination, fasten all your work securely together in the top left-hand corner with the Controlled Test examination piece(s) on top.

All questions in this paper carry equal marks.

Choose **one** of the following options from **any** section.

**Record, analyse and develop your ideas from direct observation and personal experience.**

**Section A** is appropriate for **any** Area of Study and may be chosen by **any** candidate, particularly those who prefer an open-ended starting point.

**Section B** is appropriate for **any** Area of Study and may be chosen by **any** candidate, particularly those who prefer a specific starting point.

**Section C** is intended candidates who prefer a specific design brief.

- 12 Based on your own studies of the human form, design a logo for a sports club and gymnasium called **Fit 4u**. Show how the logo would appear on the club façade, and adapted for use on a sweatshirt and a business card.
- 13 Design the front and back cover of a CD for a band called **East meets West**. Include the title 'Connections' as well as the name of the band and related imagery.
- 14 From your observational studies and photographs of glasses and bottles, design a repeat pattern for a glass manufacturer's showroom. Show how you would adapt your design for use on a carrier bag.
- 15 Design a hat, a bag and a pair of shoes that are inspired by the theme **water**. In your initial research you should study water in different forms.
