- 1 (a) Using Fig. 1 (insert), explain two ways in which the Everglades National Park provides a natural environment for many species. [4]

Content

- Significant breeding ground for wading birds (1) acts as a sanctuary for these birds (1)
- Complex habitat supporting a high density of flora and fauna (1) such as the largest mangrove ecosystem in evidence (1)
- Mixture of sub-tropical and temperate wildlife species found nowhere else in the US (1) provides a refuge for endangered and threatened species (1)
- Provides foraging and breeding grounds for birds and is a major corridor for migrating birds (1)

Taken from Fig. 1 only please.

- (b) For a named area you have studied where ecotourism is important, evaluate its economic benefits. [9]

- Income generation
- Distribution of wealth
- Provides jobs to local community
- Multiplier effect
- Long-term prospects for the park linked to financing of projects and conservation strategies
- Ability to support infrastructure
- Balance of payments
- Foreign currency exchange/income

**(c) Assess methods that authorities in areas such as South Florida, may use to prevent the negative environmental impacts caused by tourism. [12]**

- Zoning – e.g. cordoning off areas such as moving adventure tourists away from the coral reefs
- Time and space management
- Charging for entrance fees and then using the money for conservation and preservation
- Employ more workers or volunteers to oversee the smooth running of the park
- Provide education to inform visitors of the negative impacts
- Pricing mechanisms
- Carrying capacity

**2 (a) Explain two reasons why the number of tourists visiting Rome may cause negative social impacts for the host population. [4]**

- Large number of tourists compared to the number of people who live in Rome this may cause congestion (1) for people living in the area and hamper their travel to and around the city (1)
- Large number of tourists may increase the level of crime (1) and unsocial gatherings such as begging on the streets (1)
- Cultural misunderstandings (dress/appropriate to religious understanding) causing conflicts between hosts and tourists (1)
- Local shops may not sell useful products for the local community (1) may prefer to sell souvenirs as they will gain more money from this (1)
- Cost of housing may increase (1) agencies and associations may prefer to let their accommodation to tourists rather than provide for the local community. This may also cause a price increase that is unaffordable for the locals (1)

**(b) Recommend the methods cities such as Rome can use to protect their artefacts and attractions from damage from tourists. Justify each of your recommendations. [9]**

- Better policing and security at specific sites – CCTV
- Educating the tourists – to give greater understanding between cultures
- Working with tour operators and guides to create responsible tourists and link to a tourist code of conduct
- Providing more souvenir outlets
- Greater local community involvement

(c) Many areas of Rome have been designated as a UNESCO World Heritage Site. Evaluate the benefits to destinations of having such a designation. [12]

- World recognition
- Used on marketing and to sell to the public
- Protects the cultural areas of the city
- Acknowledges the significance of the area, conserves the area and preserves at risk areas
- Preserves the livelihood of locals
- Preserves the cultures, traditions and customs of the Romans
- Can lead to restoration of areas and overall safeguarding of destinations
- May give tourists even greater reason to visit and therefore increase numbers further causing more congestion, crime and loss of privacy for the locals
