## Cambridge IGCSE<sup>®</sup> Art and Design (0400) (for examination in 2017, 2018 and 2019, also available for examination in March 2018 and 2019 for India only)

We have updated this syllabus. The latest syllabus is version 3, published October 2015.

For examination in June and November 2017, 2018 and 2019. Also available for examination in March 2018 and 2019 for India only.
