Answer the THREE questions below.

The first two questions are based on the scenarios below. The scenarios are not related.

In 1972, Anytown Football Club appointed Viktor as a sports physiotherapist. Between 1972 and 1990, Viktor provided physical check-ups for all newly appointed football players. Viktor was self-employed and invoiced the football club for each examination he conducted. A number of former players are now seeking damages from Anytown Football Club, as they had been sexually abused by Viktor while he was conducting their physical examinations. Viktor died in 2016, so the former players cannot bring a claim against him personally.

Dr Penberthy is on duty in the accident and emergency department of Sunnytown Hospital when Treeve is rushed in following a surfing accident. Treeve is not responding to brain activity tests and conventional treatment is not working. Dr Penberthy decides to try an old-fashioned method of treatment which involves using an unusual drug. The procedure is against hospital policy and the vast majority of doctors would not use it. Unfortunately, Treeve dies immediately after being given the drug. An autopsy (an investigation into the cause of death) shows that Treeve's death was due to his existing injury and not due to the drug used by Dr Penberthy.

- 5 Advise whether Anytown Football Club would be vicariously liable for the sexual abuse committed by Viktor. [25]**
- 6 Advise whether Dr Penberthy would be liable in negligence for the death of Treeve. [25]**

Shaun, a nine-year-old boy, enters the Oldtown Pet Shop to find out about buying a goldfish. He sees a colourful parrot and reaches up and puts his finger in the cage. The parrot bites him, leaving him with a nasty injury. There is a sign above the cage saying, 'This Parrot May Bite'.

Bob runs a charity from his garage. He salvages and recycles old bicycles to send to Africa. Outside the garage, he has created a storage area where he has put a large pile of worn-out bicycle tyres. Bob keeps the tyres under a cover to protect them from the weather. During a freak thunderstorm, a passing drunken man pulls the cover off and later a bolt of lightning strikes the pile of tyres, setting

them on fire. The fire spreads and burns down the garage belonging to Charlie, Bob's neighbour.

- 9 Advise whether Charlie would be successful in an action in Rylands against Bob. [25]**
