# Option 1 - Raiders and Invaders: the British Isles c.400-c.1100

## How to do well

- **Hint 1:** Do not write everything you know about Vikings and Normans. This question is about making up your own mind about whether the Vikings were more successful at defeating their enemies than the Normans.
- **Hint 2:** Decide which of your notes and source material are about success in defeating their enemies.
- **Hint 3:** Make sure you compare the success of Vikings and Normans in defeating their enemies, giving your views and supporting your views with evidence.
- **Hint 4:** Remember to explain whether the Vikings were more successful at defeating their enemies than the Normans or whether they were equally successful.
- **Hint 5:** You should support your arguments with relevant evidence from sources or your own knowledge.
- **Hint 6:** Your arguments should reach a conclusion that answers the question.

# Option 2 – Power and Control: Kingship in the Middle Ages c.1100–c.1500

## **THE TASK**

'Both King John and King Edward I were more popular with ordinary people than they were with the barons.'

How far do you agree with this statement? Use your notes and source material, as well as your own knowledge, to explain your answer. [50]

## How to do well

- **Hint 1:** Do not write everything you know about King John and King Edward I. This question is about making up your own mind about whether one king was more popular than the other in their relationships with ordinary people and the barons.
- **Hint 2:** Decide which of your notes and source material are about the ways in which the actions of King John and King Edward I affected ordinary people and the barons.
- **Hint 3:** Make sure you compare each king's popularity with ordinary people and the barons giving your views and supporting your views with evidence.
- **Hint 4:** Remember to explain how each king related to the barons and ordinary people.
- **Hint 5:** You should support your arguments with relevant evidence from sources and your own knowledge.
- **Hint 6:** Your arguments should reach a conclusion that answers the question.
