



Historians have made different interpretations about the causes of the Wall Street Crash.

The following pieces of evidence refer to the causes of the Wall Street Crash.

Study these and answer the question that follows.

#### Evidence 1

This interpretation is written by Nigel Kelly, writing for a GCSE history textbook 'The USA 1919-1941', published in 1997.

He argues that there were many causes of the Wall Street Crash.

As in most events in History, there is no simple answer to the question 'Why did the Crash happen?'. Instead we have to look at a variety of linked causes, including the overproduction of goods, the availability of easy credit, the uneven distribution of wealth and finally the panic of inexperienced investors.

#### Evidence 2

This interpretation is from Cecil Roberts, an American citizen who experienced the rise and fall of the American economy, writing in his book, *The Bright Twenties*, published in 1938.

He argues that the greed of the stock market was to blame for the Wall Street Crash.

The greed and insanity of the stock market reached its peak in 1929. Everyone was buying and selling on the market. People expected to double their money quickly and for it to double again. When I saw shopkeepers and other investors risking all they owned on shares. I knew there would soon be trouble.

## **Evidence 3**

This evidence is from Roger Babson, a leading economist in 1928.

Sooner or later an economic crash is coming. The overproduction in agriculture, falling house prices and reduced trade with other countries will have a terrible impact on the economy. Factories will shut down and millions of men will be thrown out of work.
