## 1 **Message from Tudor Thomas** **WJEC Religious Studies Subject Officer**

### **Changes to GCE, GCSEs and Entry Level in England and Wales PLUS CPDs**

Please look at the important information below regarding GCE, GCSE and Entry Level Religious Studies which will have an effect on all Specifications. These changes are being introduced by the regulators Ofqual in England and the Welsh Government in Wales and will affect all awarding bodies in England and Wales. I will do my utmost to keep centres informed of the changes. Please sign up to our **Subscribe** (see 3) in order to be kept up to date with on-going developments and the changes taking place in both England. Changes are also taking place with CPD provision for the future.

Ofqual have announced changes to GCSE qualifications which will be of interest to schools registered with WJEC in England and in Wales.

## 2 **New Religious Studies Consultant appointed**

Eira Morgan has been appointed as the new Religious Studies Consultant working alongside Tudor Thomas. Eira graduated from Cardiff University with a degree in Religious and Theological Studies before completing her PGCE at Trinity College Carmarthen. Eira has taken responsibility for Entry level RE and RS as well as providing supporting for GCSE RS Specification B. Prior to working at WJEC Eira worked as an RS teacher at Caldicot Comprehensive School and currently volunteers at a primary school teaching RE to Key Stage 2 pupils.

### 4 GCSE NEWS

#### Changes to GCSEs in England

Ofqual, regulator for qualifications in England, announced that they will introduce changes to GCSEs for candidates starting two-year courses in September 2012.

For awards in summer 2014 onwards, linear assessment will be compulsory for candidates in England. They will sit all their examinations at the end of their GCSE course, rather than having the possibility of taking them at different stages during the course as they do at present. This will have an impact on centres in England who have used the 'staged assessment' pattern provided by WJEC in GCSE Religious Studies for both Specification A and Specification B.

#### GCSEs in Wales

In Wales, the Department for Education and Skills has confirmed that schools will be able to choose from two options from September 2012 onwards. **Either** they will be able to enter candidates for the new linear qualifications, where they sit all their exams at the end of the course, as in England, or they can enter candidates for separate units taken at stages during the course as they do now.

#### England and Wales and SpaG at GCSE

In GCSE English literature, geography, history and religious studies, additional marks will be awarded for the accuracy of spelling, punctuation and grammar in questions that require extended answers in exam papers from January 2013 onwards.

WJEC will offer both linear and unitised GCSE specifications, and will therefore continue to meet the needs of both Wales and England across the full spectrum of our GCSE qualifications. The subject content of the current WJEC GCSE specifications will remain unchanged.

Revised specifications showing the new arrangements will be posted on the website once accredited by the regulators. We will be advising teachers by email and post. If you would like to receive a personal update, please sign up to receive information by e-mail on the Religious Studies subject page.

#### KEY DETAILS FOR SPECIFICATION A AND SPECIFICATION B

Specification A has a systematic study of religion, **and** Specification B, involves a thematic study of some central questions and issues in human life and experience exploring the relevance of religious beliefs, values and traditions to these questions and issues.

Specification B has the added advantage of allowing schools to meet the statutory requirements of both the 1944 Education Act and the 1996 Education Act. The 'staged assessment' (i.e. one short course in year 10 followed by a further short course in year

11, which is aggregated to give a full course result) offered in both specifications will be maintained.

## FREQUENTLY ASKED QUESTIONS

### Units 1 and 2: All Topics Question (d)

The question has been raised as to whether this question 'Explain from **two** religious traditions.....' can be answered from two traditions within the same religion.

**ANSWER:** Please refer to

**2.1 Number and Combination of Religions to be Studied** (page 7) of the Specification which states:

*For each topic of the specification questions will be set requiring candidates to demonstrate knowledge and understanding of the beliefs, practices, values and traditions of:*

**either** (i) Christianity and one other principal religion

**or** (ii) a Christian tradition within the broader context of Christianity.

*In alternative (ii) candidates will be expected to study one Christian tradition throughout all four topics and be able to place the tradition within the broad context of the Christian faith so that the study is balanced in terms of breadth and depth. They will be required to answer questions on each topic which will anticipate a knowledge and understanding of two Christian traditions.*

Candidates can therefore answer from two branches of Christianity and should state which ones they are referring to in the space marked 'religious tradition 1'. It may be that there is little or no difference between the two traditions, e.g. Roman Catholicism and Anglican. If this is the case, candidates must write everything in full twice. 'Roman Catholics believe the same thing.' will score no marks.

Candidates must be aware that in either Unit Paper: Unit 1 (Religion and Life Issues) or Unit 2 (Religion and Human Experience) they may be asked for the viewpoint from **one** religious tradition only. There will be sufficient specification content for candidates to gain the full marks.

## 5 GCE NEWS

**In England** the regulators have decided that with effect from 2015 AS examination opportunities will not be offered in January. **Therefore WJEC will not be able to accept entries from centres in England for AS RS for January 2014 and in subsequent years.**

**In Wales** WJEC is still awaiting the decision of the Welsh Government. At the moment WJEC will be offering AS examinations in January 2014. If the position changes WJEC will inform centres in Wales.

The Secretary of State for Education Michael Gove has announced that in England linear specifications will be introduced in 2015 for first examination in summer 2017. In Wales modular GCE courses will continue for the foreseeable future.

## 6 ENTRY PATHWAYS – HUMANITIES

Entry Pathways-Humanities has now been approved by the regulators Ofqual in England and DFES in Wales. Please refer to the statement on the Entry Pathways Humanities website page and details of forthcoming CPDs.

The subject offered under the Humanities Pathways include: History, Geography, Religious Studies, Humanities and French. These subjects are offered at Entry level 2 and Entry 3 only. Centres will be able to choose to study units all in one subject area for example Religious studies, or mix and match from any other subject within the Humanities Pathway or a unit from another Pathway can be included in the Award or Certificate for Humanities e.g. Working as part of a group or a Religious Studies unit for example, can be included in another pathway such as personal and Social development. All Entry Level Pathway units are internally assessed and externally moderated (through scripts). Assessment will be criteria based rather than mark based.

When there are no vacancies, then your application will be kept in our Reserve bank and referred to as and when vacancies occur.

## 9 WJEC SECURE WEB-SITE

The WJEC Secure Website can be accessed by authorised staff at Centres that work with WJEC. This is often the Examinations Officer within the Centre. Once a Centre is registered, access is available to a range of resources including circulars, past papers and marking schemes. There is also the facility for entry/amendment file uploads and the ability to make online post-results enquiries.

If your Centre is not registered, please send an email to [securewebsite@wjec.co.uk](mailto:securewebsite@wjec.co.uk) stating centre number, centre name, contact name and contact email address. Only the centre examinations officer should send this email. WJEC will then get a letter of registration out to your centre as soon as possible (normally within two working days). Please indicate on your email if your registration is urgent. Once registered, the examinations officer can then register other members of teaching staff additional limited access accounts themselves.

## 10 CPD (INSETs)

**The situation in England will change with effect from 2014** when award organisations will no longer be allowed to provide 'face to face' CPDs on an annual basis. However, award organisations will be allowed to provide CPD when specifications are revised.

The Welsh Government has not yet made a ruling for school in Wales reading CPD in 2014. WJEC is currently responding to a consultation being WJEC conducted by the regulators for England Ofqual.

CPD is the new acronym for INSET i.e. Continuing Professional Development. Every year, a number of teachers miss out on CPD provision that is available for this subject because of being unaware of the date(s). CPDs for all Religious Studies subjects *normally* take place in the autumn of every academic year. When you visit the WJEC website, look under **Teachers** for details and to download an application form to register. In 2013, as in 2012 in Wales there will be a number of LEA organised CPDs when schools in a particular LEA will be closed for teachers to attend CPD in the authority. Teachers from others LEAs, independent schools are not able to attend these particular events.
